

## WONDERISLANDS.COM - PRIVACY POLICY

This site ("Site" or "**Wonderislands.com**") is owned and operated by Compedia Virtual Worlds (CVW), Inc. ("**Compedia**").

**Wonderislands.com** is acting in accordance with the [Children's Online Privacy Protection Act of 1998](#). Our information collection practices are described below.

**We urge kids to check with their parents before entering information on any website and we urge parents to discuss with their kids restrictions regarding the online release of personal information to anyone they don't know.**

Please read this Privacy Policy carefully. By visiting and using this Site, you acknowledge and agree that your use of our Site, and any dispute over privacy, is governed by this Privacy Policy and our [Terms of Use](#)

### **What Information Is Collected?**

At **Wonderislands.com**, we limit our collection of personal identifiable information of our users to the registration process which is done by the parent or the guardian of the child who will be using the Site. We collect the following information from the parent/guardian upon registration to our Site: parent's/guardian's name, password, parent's/guardian's email address, name, phone number and date of birth of each of the children that are permitted by the parent/guardian to use the Site under his/her specific user name; and, at the parent's or guardian's discretion, we further collect the child's nick name, prime language and fields of interest ("**User Information**"). This information is collected so kids can participate in activities without giving unnecessary personal information and to receive personalized and appropriate learning experience and materials. **Wonderislands.com** does not condition a kid's participation in any of our online activities on the disclosure of more information than is reasonably necessary to participate in the activity.

### **Use of Information**

The User Information may be used by us solely for providing the services on Wonderislands.com, and for communications related to Compedia services such as sending, newsletters, notices about new features, or other information of interest to you relating to Wonderislands.com. If you are participating in our beta program, then, during the beta trial period, your membership in the beta program will result in your receiving emails and other forms of communications. After the beta period, you will be able to opt out of receiving these communications through this Site.

The Site and the services therein are constantly evolving and changing in content and in features. User Information helps guide such changes and evolution. Accordingly, we may access non personally identifiable information such as your computer's IP Address, and may gather aggregated information about your and other users' use of our Site, including, without limitation, the manner, consistency, duration and other information identifying the ways in which you and other users as whole use and access Wonderislands.com and/or services therein. We also may aggregate various statistical and other data related to such use, including, without limitation, ascertaining aggregated usage, patterns and other behavioral information in order to

expand and better develop our Site and services to enhance your experience. This information does not include individually identifiable personal information.

Compedia will not distribute, sell or rent any User Information to other people or nonaffiliated companies (except for sale of Wonderislands.com as a whole to another entity, where the acquirer shall undertake to materially comply with this Privacy Policy) except to enable the provision of services on our Site or when we have your permission to do so. Notwithstanding anything to the contrary, you acknowledge, consent, and agree that Compedia may access, preserve, use, and disclose your User Information, if required to do so by law or in a good faith belief that such access, preservation or disclosure is reasonably necessary to: (a) enforce the

**Wonderislands.com** Terms of Use (b) respond to your customer service requests; (c) comply with legal process; and/or (d) protect the rights, property, or personal safety of Compedia, its users, or the public.

### **Cookies**

Compedia places cookies on your computer to retain your individual preferences and improve your user experience with our site and services, as well as to tell us what features of our site, services or software are most popular. We do not store any personal identification information in cookies, nor do we use cookies to obtain any personal information from you. You can change the configuration of your browser in such a manner that you will not be able to receive any cookies during your use Compedia services, software or website. In that event, your access or use of certain parts of our site, software or services, may be restricted.

### **Parental Access**

At **Wonderislands.com** we want to help parents ensure that their kids have a safe and fun online experience. For this purpose, Parents (or guardians) can print out and mail or fax us a signed form that allows them to review any identifiable information collected about their child, request that such information be deleted, and/or that there be no further collection or use of their child's information. Compedia takes steps to verify the identity of parents or legal guardians requesting information about a child and to ensure that the person is in fact the child's parent or legal guardian.

### **For kids**

Remember to be smart online. Do not give out your full name, e-mail address, home address, telephone number or any other personal information that would enable someone to contact you either online or offline, without first asking your parent or guardian for permission. Sometimes on our **Wonderislands.com** site we will ask you for your first name and e-mail address along with your parents' e-mail address. We do this so that we can contact your parents to let them know that you have communicated with us, and that we have collected this information from you.

### **Security**

Compedia takes commercially reasonable organizational and technical steps to protect the privacy of your personal identifiable information. Compedia will make best efforts to ensure that your information will be accessible only by authorized employees of Compedia who need to have access to this information in order to provide you with the services on Wonderislands.com. However, you should be aware that there is no data that is transmitted over the Internet that can be guaranteed 100% secure in

transmission or safe from theft or illegal capture, and therefore we do not guaranty absolute resistance from unauthorized access.

Compedia may periodically update this Privacy Policy. We will notify you about significant changes in the way we treat personal information by placing a prominent notice on our website. In addition, the date at the top of this Privacy Policy will indicate when this policy has most recently been revised; we encourage you to periodically revisit this Privacy Policy to ensure that you are familiar with the current version. **Your continued use of the Compedia website, after any change to the policy constitutes your acceptance of this Privacy Policy.**
